OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF

WINNING. Void where prohibited by law and outside the United States. Subject to all federal, state and local laws, regulations, and ordinances. Sponsor’s computer is the official time keeping device for this Sweepstakes.

Normal access, phone, and usage charges imposed by your telephone, email or internet provider may apply.
